The meeting was called to order at 6:30 p.m. by Pobla Gallier, President The invocation was given by Charles Boyce The pledge was given in unison by everyone.

- 3. During Open Forum Stephen Bryant addressed the Board regarding the accomplishments and successes of the Public Football Team. They shared their desire to see this program translate into a future football team for OISD. 70+ children currently participate and are representing Onalaska proudly. The team saw their first victory over Livingston recently.
- 4 Hannah Williams, Elementary-Intermediate School Principal, reported the following:

Enrollment is 568 students; attendance is at 97.4%. About 150 grandparents enjoyed lunch in honor of Grandparents Day on September 10<sup>th</sup>. See you at the Pole is at the flag pole from 7:00-7:20 on Wednesday the 22<sup>nd</sup>. OES will hose Parent Read Well Night for Kindergarten through second grade students and their parents. The goal is to provide and overview of the Read Well program. A light meal will be provided.

Charles Boyce, Onalaska Junior-Senior High School Principal, reported the following: Enrollment is 415 students; attendance at 95.66% OJSH is host for FFA District Officer Training with 24 schools participating. On Sept 11<sup>th</sup> the Band participated in the Northwest State University "All Honors Band", "All Honors Choir" and "Color Guard Day" in Nachotoches, LA Volleyball Teams have started District play for both JH and HS.

Lynn Redden, Superintendent, reported the following: Ground Force Construction continues to do preliminary design work for the Science Facilities. An update was also given on Qualified School Construction Bonds and a presentation from James Ard, Food Service Director showed that profits are increasing in that department when compared with last years numbers.
