Meeting was called to order at 11:47am. Mrs. Danna Mitschke, Special Programs Coordinator, welcomed SHAC Members and introductions of the 24-25 SHAC committee members was completed.

UPDATES FROM 23-24 (Old Business):

Mrs. Mitschke shared the 23-24 SHAC Annual Report from the School Board meeting on July 15, 2024 with the committee. No questions were presented.

24-25 SHAC General Business:

Mrs. Mitschke reviewed the OISD SHAC Bylaws and FAQ documents with the committee. There were no changes made to the bylaws.

The OISD Wellness Policy was provided to the SHAC committee. Mr. Ard, Director of School Nutrition, led the introduction of the Wellness Policy with the SHAC committee.

Mrs. Mitschke explained each of the 5 subcommittees to the SHAC members and asked each to sign up for the subcommittee of their choice.

The Well Cat Health Fair was held on September 12, 2024 and addressed Educational Services, Medical Services, State Support Services, Mental Health/Social Emotional Learning, Safety, and Wellness & Nutrition. There were 72 participants and 25 vendors who provided resources to our community.

There is an upcoming Immunization Clinic on October 11, 2024 at OJSH. The target groups are PreK, Kinder, and 7th grade students. State mandated immunization deadline is November 1st and nurses have sent out communication to the families of the students in these groups. Also, publication of the event is currently happening on the marquee's, district web page, and 3 Remind messages are scheduled to go out to remind parents of the opportunity for reduced price vaccines.
